



General phase-down schedule





How to calculate blowing agents mixture GWP according to EU 517/2014?



Formula

Total GWP = Σ (Substance X % x GWP) + (Substance Y % x GWP) + ... (Substance N % x GWP)

e.g. HFC 365mfc / 227ea at ratio 93/7 GWP = $(794 \times 93\%) + (3220 \times 7\%) = 963 \text{ kg CO}_2$ equivalent

- Reference GWP values
 - HFCs : Annex I
 - HFOs (=unsaturated HFCs) : Annex II
 - Pentanes : Annex II, GWP = 5 for all isomers
